

## **PROGRAM DESCRIPTION**

The Master of Arts in Health Policy Studies is a program that promotes the common good by ensuring that the health deliverv systems address the concerns of the poor and the marginalized. There are two approaches or tracks to fulfill the requirements of this degree program, one of which is the Health Science Track. This track makes use of the different fields of public health as basis for health policy development. The various fields in public health include biostatistics, epidemiology, health care organization, health economics, health research, and health service administration.

- Demonstrate a pro-active, social, and culturally relevant analysis of priority health policy issues;
- Utilizes an interdisciplinary approach to developing ethical, relevant and responsive health policy analysis and research towards identified policy-related problems and issues that ultimately, contribute to nation-building:

- Creates an inclusive, participative, and meaningful engagement towards consensus building in health policy development in leadership capacity; and
- Engage in lifelong learning.
