

DIPLOMA IN CLINICAL MEDICINE (OBSTETRICS - GYNECOLOGY)

Those who opt not to pursue the Master of Science in Clinical Medicine degree may be awarded a Diploma in Clinical Medicine (Obstetrics Gynecology) upon completion of 28 units of formal courses with a general weighted average of 2.00 or better and passing the comprehensive examination.

The student is not required to submit a thesis. The Diploma has the same learning objectives and the same academic requirements as the Master of Science program. This program shall be another option for those who may want post-graduate studies in Obstetrics and Gynecology, but not a master's degree.



MASTER OF SCIENCE IN CLINICAL MEDICINE (OBSTETRICS AND GYNECOLOGY)



The Department of Obstetrics and Gynecology (OB-GYN) of the University of the Philippines Manila, College of Medicine (UPCM) and Philippine General Hospital (PGH) prides itself in providing a world-class premier training in Obstetrics and Gynecology. In 1907, the Department offered its first formal residency training program, and since then has been offering not only the general OB-GYN training program but all the subspecialty programs recognized by the local and international specialty societies.

Today, many graduates of the residency and fellowship training programs of Obstetrics and Gynecology have become much-sought in their respective specialties - not only as clinical practitioners, but also as teachers in the academes, mentors in research projects, and administrators and leaders in the communities. Although the residency and fellowship training programs have prepared the graduates well for clinical practice, the additional responsibilities warrant an endeavor for a program to strengthen the academic and administrative capabilities of the OB-GYN practitioners all over the country.

The Master of Science in Clinical Medicine, with a track in Obstetrics and Gynecology is, thus a graduate program designed to produce such expert OB-GYN practitioners, knowledgeable and skilled in teaching, research, and administration.

- **A maximum of 5 years is given to a student to finish the program.

Living accommodations for students may be provided in privately-owned housing units/dorms/apartment hotels. Dorms offer lodging and/or board. There are privately-owned eateries around the school.

The following are the minimum NGOHS requirements:

- 1. Must have an MD degree (applicants who are not doctors nor specialists in Ob-Gyne but are holders of post-graduate degrees may be admitted in special circumstances, based on the evaluation of the departmental Graduate Education Committee.)
- 2. Must have a weighted average of 2.00 or better in Ob-Gyne.
- 3. Graduated from an accredited Ob-Gyne residency program by the Philippine Obstetrical and Gynecological Society.
- 4. Must pass an entrance interview.
- 5. Foreign students who have received formal training in ObGyne may be accepted to the program, subject to the fulfillment of other requirements as needed by the University.
- 6.Duly accomplished Application Form (downloadable through the NGOHS website: ngohs.upm.edu.ph)
- 7. Comply with the General requirements found on the 2nd page of the Application Form (UPM-NGS-OP-01F1)

Graduation Requirements:

- A general weighted average not lower than 2.00 in major courses and in all courses taken.
- \square Passing a comprehensive examination in the department.
- Completion of the thesis, which must be an original research work that constitutes a substantial contribution to knowledge or skill in Obstetrics and Gynecology, through oral and written form. Satisfactory completion and submission of the required hard bound copies of thesis, and electronic copy of manuscript.
